The actual number of shares of common stock that may vest, if any, is contingent on the Company's average Adjusted EBITDA as compared to target Adjusted EBITDA and the Company's total shareholder return ("TSR") relative to the TSR of identified peer companies achieved over the three year period from 2018 through 2020, with potential to earn a number of shares of common stock between 0% and 200% of the number of target PSUs awarded. This 2018 PSU award will cliff vest, if at all, after the performance period ending December 31, 2020.
